A new member is defined as anyone who does not currently have an account at HACU and must be at least 18 yrs. old for all loan approval including a Visa Card.

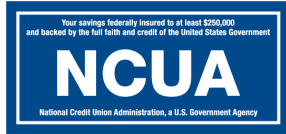


Summer vacation loans remain available thru July 31st.
